No work stoppage monitored during the month.

- 23 new NS/L filed since January, 9 cases filed during the month
- Disposition rate: 40% (22 of the 55 cases handled)
- Settlement rate: 40% (22 of the 55 cases handled)
- Average duration to settle: 70 days
- Monetary benefits: Php28.5-M benefitting 250 workers

III. PREVENTIVE MEDIATION (PM)

- 72 new PM cases filed since January, 35 cases filed during the month
- Disposition rate: 35% (37 of the 106 cases handled)
- Settlement rate: 33% (35 of the 106 cases handled)
- Average duration to settle: 39 days
- Monetary benefits: Php106.6-M benefitting 95 workers
