# Alternative Dispute Resolution Updates

**Preliminary** 

As of 30 April 2025

This ADR Update records in brief the collective accomplishments of NCMB as of April 2025.

## I. PREVENTIVE MEDIATION (PM)

- 24 cases pending at the beginning of the year
- 111 new cases have been filed since the start of the year (26 new cases filed in April)
- 20,324 workers involved in new cases filed for the year (13,249 male workers; 7,075 female workers)
- 135 total cases handled as of 30 April 2025
- Disposition rate: 86% (98 of the 114 total net cases handled)
  - 76 cases disposed of within the process cycle time (PCT = 35 days)
  - 22 cases disposed of beyond PCT
- Settlement rate: 82% (93 of the 114 total net cases handled)
- Average duration to settle: 27 days
- 37 cases pending as of 30 April 2025
  - o 21 pending cases are 35 days old or younger
  - 16 pending cases are older than the PCT
- Monetary benefits: Php 33,011,223 benefitting 675 workers

#### II. NOTICES OF STRIKE/LOCKOUT (NS/L)

- 30 cases pending at the beginning of the year
- 36 new cases have been filed since the start of the year (4 new cases filed in April)
- 10,726 workers involved in new cases filed for the year (7,028 male workers; 3,698 female workers)
- 66 total cases handled as of 30 April 2025
- Disposition rate: 73% (43 of the 59 total net cases handled)
  - 34 cases disposed of within the process cycle time (PCT = 60 days)
  - 9 cases disposed of beyond PCT
- Settlement rate: 51% (30 of the 59 total net cases handled)
- Average duration to settle: 43 days
- 23 cases pending as of 30 April 2025
  - o 7 pending cases are 60 days old or younger
  - o 16 pending cases are older than the PCT
- Monetary benefits: Php 469,625,896 benefitting 3,391 workers

## III. ACTUAL STRIKES/LOCKOUTS (AS/L)

- No pending case at the beginning of the year
- 8 work stoppages monitored since the start of the year (3 new work stoppages monitored in April 2025)
- 1,873 workers involved in new cases declared for the year (1,853 male workers; 20 female workers)

# IV. SINGLE ENTRY APPROACH (SEnA)

- 1,020 Requests for Assistance (RFAs) pending at the beginning of the year
- 1,106 new RFAs have been filed since the start of the year (297 new RFAs filed in April)
- 2,126 total RFAs handled as of 30 April 2025
- Disposition rate: 72% (1,382 less 31 RFAs dropped from the dockets and 57 RFAs dropped due to lack of interest over the 1,800 total net RFAs handled)
  - 1,358 RFAs disposed within the process cycle time (PCT = 30+15 days)
  - o 24 RFAs disposed beyond the PCT
- Settlement rate: 56% (1,005 of the 1,800 total net RFAs handled)
  - 989 RFAs settled within the process cycle time (PCT = 30 days +15 days)
  - 16 RFAs settled beyond the process cycle time
- Average duration to settle: 17 days
- 744 pending RFAs as of 30 April 2025
  - 238 RFAs pending within the process cycle time (PCT = 30 days)

- 53% disposition rate (547 of the 1,025 total cases handled)
  - 373 cases disposed of within the process cycle time (PCT = 90 days)
  - 174 cases disposed of beyond PCT
- Average duration to decide:
  - o 90 days from the date of acceptance by the arbitrator
  - 21 days from submission for resolution
- 478 cases pending as of 30 April 2025
  - 176 VA cases pending within process cycle time (PCT = 90 days)
  - 296 VA cases pending beyond process cycle time
- Monetary benefits: Php 1,618,883,143 benefitting 793 workers

- 5,638 existing LMCs nationwide as of April 2025 (1,694 in organized companies and 3,944 in unorganized companies)
- 98.57% or 5,319 out of 5,396 companies with LMCs were not involved in AS/L, NS/L, PM cases during the period
